AN ORDINANCE

To amend the Heavy Fuel Oil (Prohibition of Carriage and Use) Ordinance 2019 to eliminate the carriage or use of heavy fuel oil on a vessel in the Territories and maritime zone.

ENACTED by the Commissioner for South Georgia and South Sandwich Islands —

1. Title

This Ordinance is the Heavy Fuel Oil (Prohibition of Carriage and Use) (Amendment) Ordinance 2020.

2. Commencement

This Ordinance comes into force on 31 December 2020.

3. Amendment of Heavy Fuel Oil (Prohibition of Carriage and Use) Ordinance 2019

This Ordinance amends the Heavy Fuel Oil (Prohibition of Carriage and Use) Ordinance 2019.

4. Section 3 amended - Interpretation

The definition of “**designated area**” is omitted and replaced with —

““**designated area**” means —

- (a) the territorial waters; and
- (b) the maritime zone established by Proclamation No. 1 of 1993,

as illustrated on the map in the Schedule.”.

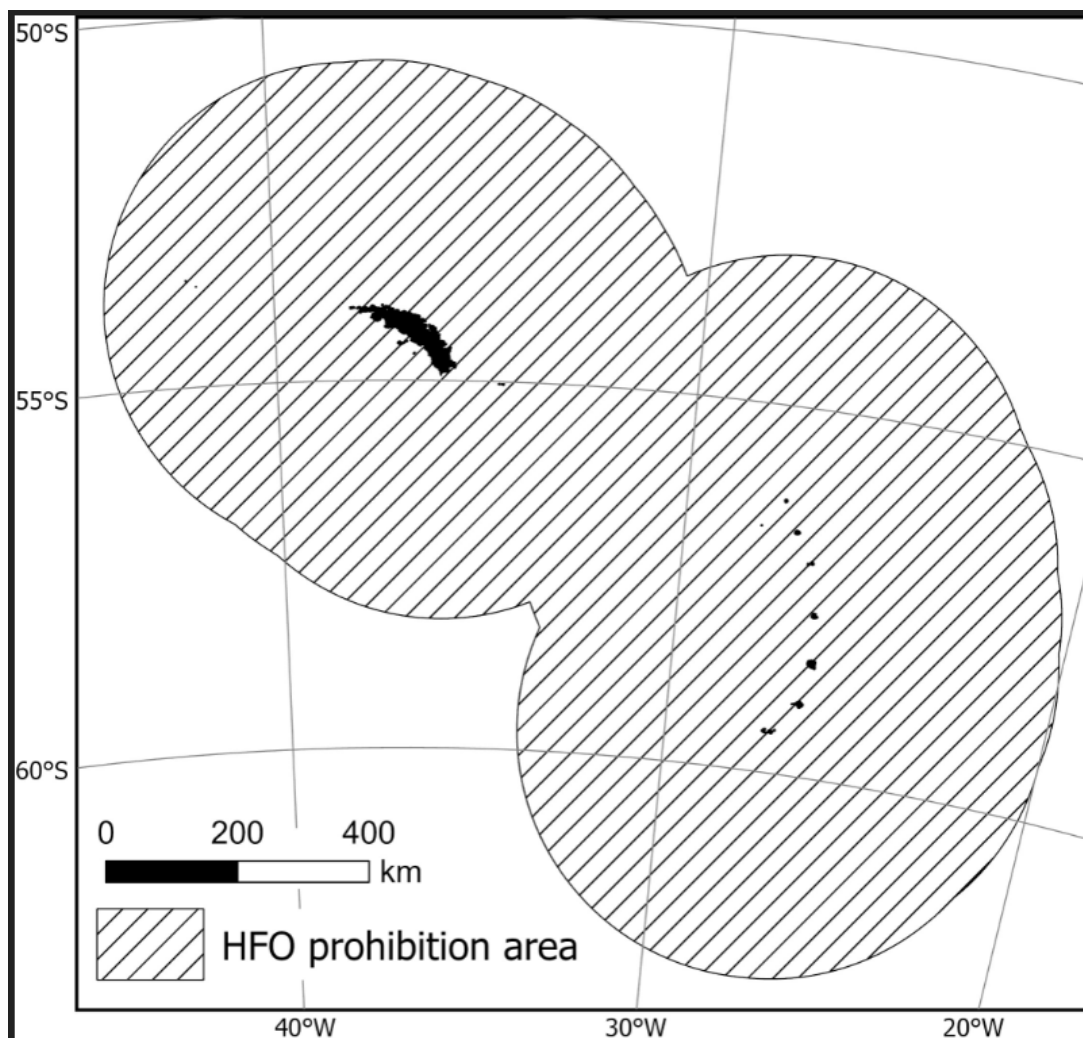
5. Schedule repealed and replaced

EXPLANATORY NOTE

(not part of the Ordinance)

This Ordinance amends the Heavy Fuel Oil (Prohibition of Carriage and Use) Ordinance 2019. The amendment provides for the elimination of carriage or use of heavy fuel oil in an extended designated area with effect from 31 December 2020. This will enable better marine environmental protection.
