## Notes:

- 1. This table is informal and has no official status.
- 2. There are many records and tables listing the Ordinances that were enacted in and for Falkland Islands and the Dependencies from 1853 onwards. Printed versions of at least some of the Ordinances are available from 1853.
- 3. The Falkland Islands National Archive holds several hand written copy books and ledgers that list and set out the Ordinances in entirety from 1846 onwards. This table has been created from them.
- 4. The earliest Ordinances all contained, what are now termed, 'sunset clauses.' A sunset clause provides for the automatic expiry of the Ordinance, typically on a fixed date in the future, or expressed with reference to when the Ordinance first came into force.
- 5. The Legislative Council passed several 'confirmation' Ordinances in this period extending the life of an Ordinance that would otherwise have expired through the operation of a sunset clause.
- 6. None of the copy books and ledgers examined had any Ordinances for the year 1852. In one of the books there is a reference to the Council being constituted of 'too many members' and that the six Ordinances they appear to have passed were 'therefore illegal.' The note continues "Acts done under them were legalised by No5 1851." This is understood to a reference to the Administration of Justice Ordinance 1851 in the
