An Ordinance

Further to amend the Income Tax Ord-Title. inance.

[1st January, 1962]

Date of commencement.

ENACTED by the Legislature of the Colony of the Falkland Enacting clause. Islands, as follows:—

1. (1) This Ordinance may be cited as the Income Tax Short title and (Amendment) Ordinance, 1962, and shall be read as one with the commencement. Income Tax Ordinance (hereinafter referred to as the principal Cap. 32. Ordinance).

- (2) This Ordinance shall be deemed to have come into force on the 1st January, 1962.
- 2. Section 19 of the principal Ordinance is amended by deleting the figure "20" and by substituting the figure "12½".

3. Section 21 of the principal Ordinance is amended —
