Further to amend the Income Tax Title Ordinance.

(15th February 1971)

Date of commencement.

ENACTED by the Legislature of the Colony of the Falkland Enacting clause. Islands, as follows —

- I. This Ordinance may be cited as the Income Tax (Amendment) Ordinance 1971, and shall come into operation on the 15th day of February 1971.

An Ordinance
