**Notes:**

- (1) This list has been compiled using the table published in the 'Revised Edition of the Laws etc.' that came into force on 12 March 1953 as a base and then comparing that table with the notices published in the Gazette.
- (2) Reference to Trade Unions and Trade Disputes Ordinance 1942 does not appear in the table in the 'Revised Edition of the Laws etc.' however it does appear in the Gazette notice – hence being included in this list.
- (3) Most of the titles to the Ordinances, when referred to in their respective Gazette notices, were prefixed with the definite article 'The.' That practice is not followed in this list.
- (4) Where there is no entry in the initial notice number column this denotes that the list in 'Revised Edition of Laws' indicates that the particular notice was 'unnumbered' in the relevant Gazette.
