APPROPRIATION (2023) ORDINANCE 2022

(No: 5 of 2022)

(enacted: 23 December 2022) (published: 23 December 2022) (commencement: on publication)

AN ORDINANCE

To authorise withdrawals from South Georgia and the South Sandwich Islands funds of money for use during 2023; and for connected purposes.

ENACTED by the Commissioner of South Georgia and the South Sandwich Islands —

1. Title and commencement

This Ordinance is the Appropriation (2023) Ordinance 2022 and comes into force on publication in the *Gazette*.

2. Appropriation of £8,995,324 for 2023

- (1) The Financial Secretary may withdraw sums of up to £8,995,324 in total from South Georgia and the South Sandwich Islands funds, for use during the financial year 1 January to 31 December 2023.
- (2) Any sums withdrawn under subsection (1) may be applied during 2023 in accordance with the Schedule.

3. Retrospective authority for pre-commencement withdrawals

- (1) Subsection (2) applies to a withdrawal if
 - (a) it would have been authorised by section 2; but
 - (b) it was made before this Ordinance comes into force.

(2) A withdrawal to which this subsection applies is to be treated as having been made lawfully.
